- c) To further consider the siting of a pavilion.

  Cllr Stanbury provided an update on the location of the pavilion, which would be at the end of the bank in the Recreation Field, a gate could be provided in the fence line for dog walkers, and it was agreed to pursue with the Planning Authority.
- d) To consider quotations for installation of the basket swing. It was agreed to remove this item from the Agenda until it can progress.

#### 2405/19 Highway Concerns

Meeting ended at 8.05pm.

Cllr Boxall would like to see a 20mph speed limit implemented in the village and was asking if the PC would support a scheme. It was noted that evidence would be required for a scheme and a community speed watch would be required to support the case. Members were informed that a coordinator for the speed watch would need to be appointed to undertake the training and progress. Cllr Boxall agreed that she would consider the role.
